TEACHING AND CURRICULUM DESIGN

The Compassionate Practice Faculty, (2019-Ongoing) Curriculum Designer and Assistant Course Director, The Compassionate Practice Course *TCU School of Medicine*

My appointment as the Director of Narrative Medicine for the School of Medicine falls underneath the purview of the Department of Narrative Reflection and Patient Communication (NRPC), which develops the foundational Compassionate Practice patient-centered communications curriculum. We are an interdisciplinary team that integrates the methodologies of theatre, population health/social justice, and narrative medicine into our approach to teaching empathetic, self-reflexive communication. Our longitudinal medical student curriculum spans across the students' four years of medical school, beginning with a first course that frames arts and humanities as methodologies for communication practice. We will also have designated course time in our second- and third-year didactics (called "Learning, Application, and Pondering sessions). Finally, we appear extensively in other places of the School of Medicine's broader curriculum for students as well as in faculty development and para-curricular support.

Faculty. Longitudinal Integrated Clerkship Course (2020-Ongoing)

I am directly responsible for the students' Narrative Medicine Essay assignment, which is a longitudinal creative non-fictional project affiliated with their clinical rotations that begin from their first year. These essays are evaluated on the basis of their demonstrated critical thinking and introspective abilities, using a rubric that is hybrid version of established from other medical schools with categories that are more typically found in writing and literature courses. My role in the school has been to 1) create a working definition of Narrative Medicine that combines the field's established understanding of itself with an appropriate practical application to the SOM's needs; 2) develop the assignment within the curriculum in a way that is accessible and understandable to both students and faculty; 3) develop the assessment tools utilized to evaluate this assignment on a consistent basis in the SOM; 4) teach the Narrative Medicine and close reading/writing curriculum and its practical application to patient communication; 5) support student, faculty, and staff interests in the field of Medical Humanities/the arts by alerting people to opportunities in the field and by offering weekly "Writing Office Hours."
